




Repsol in Alaska

- Repsol offices are located in JL Tower in Midtown Anchorage


Repsol Portfolio in Alaska





Repsol North Slope Acreage






Repsol In Alaska – Operations





Wells Drilled and Planned






2012 Program Recap



2011/2012 Operations Area




- Constructed 48 miles of ice road
- Attempted to drill 4 wells
- Had drilling incident at Q2
- Responded to Q2, cleaned up spill
- Ultimately, completed 2 wells.Q4 and K1.

2013 Program Recap




2012/2013 Operations Area



- Constructed 38 miles of ice roads, and ice air strip
- Drilled 3 wells: Q1, Q3, Q6
- Encountered hydrocarbons in all 3 wells
- Flow tested 2 wells: Q1, Q6
- Investigated gravel source areas and soil characteristics in possible development area

- Construct 22 miles of ice roads

- Q5 and Q7 will appraise last year's discoveries

Oil Tax Reform is vitally important to Repsol

Oil Tax Reform puts Alaska in line with other areas of opportunity

A competitive tax structure allows marginal fields to be developed. A discovery that wouldn't have been commercial under the old tax law, might be commercial under the new. Commercial projects get developed.

Oil Tax Reform



Predictability of the regulations and the tax structure is key in making investment decisions.

To invest the hundreds of millions of dollars to bring a field online, a company needs to have reasonable assurance that the tax structure is stable.

We were disappointed when the Referendum was placed on the ballot, but we are hopeful that voters will Vote No on One, and will support investment in Alaska.
