Alaskans for Better Government is a ballot initiative campaign to create an equal relationship between the State of Alaska and Tribes.

Situation

The federal government, Alaska court system, and executive branch all formally recognize the sovereignty of Alaska's 229 Native Tribes. *Alaska statute does not.*

Challenge

Without a statute creating a permanent relationship, the State has stalled on meaningfully addressing issues impacting all Alaskans and engaging with Native Tribes as equal partners.

Resolution

What is the best path forward to establishing recognition at the state level? What will meaningfully change as a result? What will stay the same?



State recognition of Tribes is a critical way to unlock Alaska's problem solving potential

- **POWERFUL SYMBOL:** This is an opportunity for Alaskans to come together and affirm our Alaska Native heritage
- **EXPAND PROBLEM SOLVING CAPACITY:** A government-to-government relationship will utilize the Tribes' knowledge of their regions for more effective policy-making on issues like education, homelessness, child welfare, and rural and public safety to benefit all Alaskans
- **REDUCE GOVERNMENT REDUNDANCY:** The State of Alaska has sued the Tribes more than any other state in the country the consistent losses waste Alaskan taxpayer dollars
- ACCESS NEW MONEY: An equal partnership would allow the State and Tribes to leverage their status, infrastructure, and funds to generate millions for investment across Alaska





Recognizing Tribes is a matter of *respect.*



This initiative will not:

- Grant or alter Tribal or State sovereignty
- Create new legal authority or jurisdiction for Tribes or the State
- Change the federal government's relationship with Tribes or the State
- Create a Trust Responsibility between Tribes and the State

Dear Representative Zulkosky:

Thank you for reaching out regarding House Bill 123, State Recognition of Tribes. You have asked if the Alaska Oil and Gas Association has any concerns with the bill as currently written. This letter serves as our response.

Upon review and after verifying with our membership, AOGA has found nothing of concern in the bill language of House Bill 123 (version A). Alaska Native tribes referenced in the bill are currently recognized by the United States government under federal Indian law. Furthermore, nothing in this legislation appears to relinquish the State of Alaska's authority over particular lands, peoples, or activities, create any additional burdens on the State or private industry, or impact the rights of Alaska Natives as set forth in the Alaska Native Claims Settlement Act or under other applicable law.



THIS INITIATIVE WILL:

- Bring Alaskans of all political stripes together in celebration of our heritage
- Utilize the strength and expertise of Tribes and the State in creating solutions on issues like rural public safety, child welfare, healthcare and education.
- End the series of ineffective, divisive, and expensive lawsuits between the State and Alaska Tribes
- Create a clear and consistent framework for partnership between Tribes and the State to capitalize on opportunities for **new funding** for Alaska


